### 12.2 Persistence and degradability

AEROBIC: Glycerin, present at 100 mg/L, reached 63% of its theoretical BOD in 2 weeks using an activated sludge inoculum at 30 mg/L in the Japanese MITI test (1). Biodegradation rate constants of 0.258/day and 0.200/day in respirometric test systems employing activated sludge have also been reported, corresponding to 68% and 78% degradation, respectively (2).

### 12.3 Bioaccumulative potential

An estimated BCF of 3 was calculated in fish for glycerin (SRC), using a log K<sub>ow</sub> of 1.76 (1) and a regression-derived equation (2). According to a classification scheme (3), this BCF suggests the potential for bioconcentration in aquatic organisms is low (SRC).
